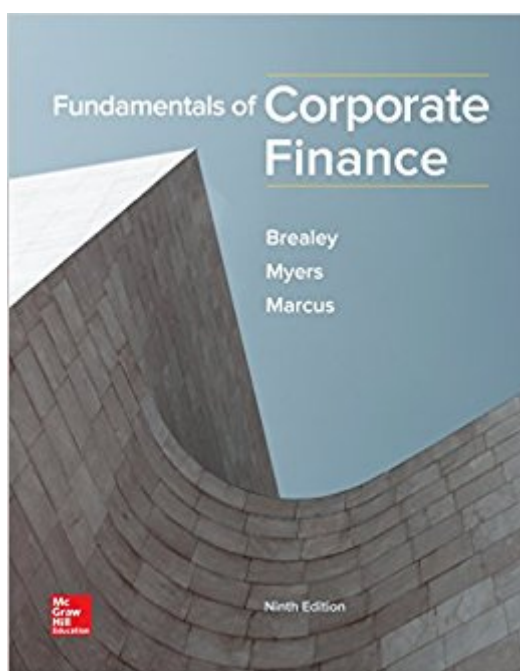

Myers is the Gordon Y Billard Professor of Finance at MIT's Sloan School of Management. Dr. Myers is a director of The Brattle Group, Inc., and is active as a financial consultant.
