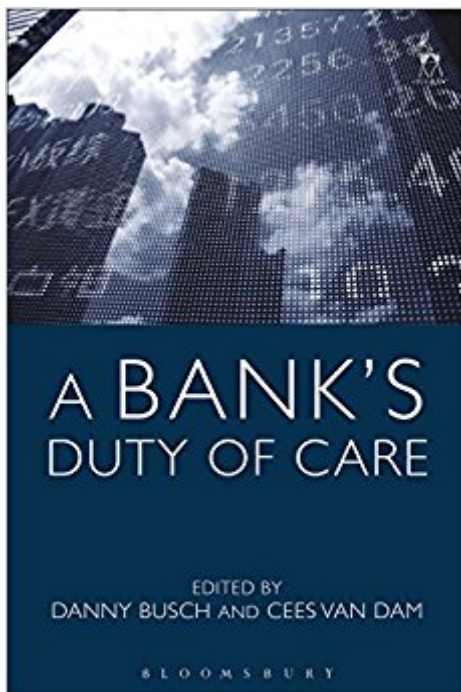

The scope of the duty of care of banks has expanded to not only include protection of consumers against unclear risks of complicated products, but also protection of professional parties against more obvious risks of relatively straightforward products. This topic raises many questions, both at a theoretical and practical level.
