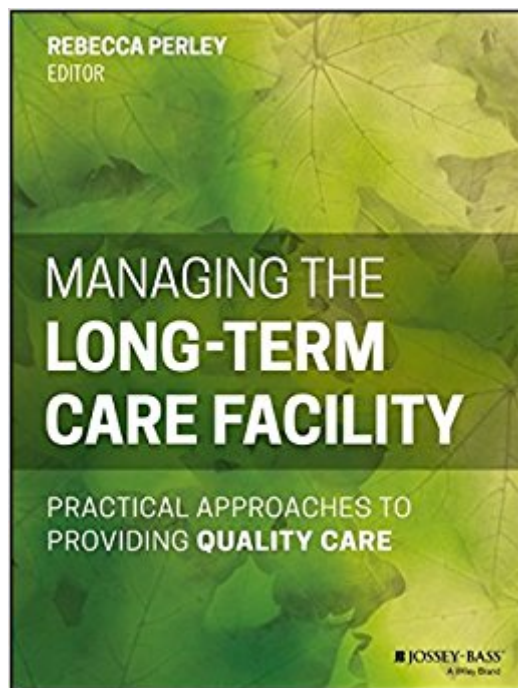

This comprehensive text is both refreshing and timely. At the heart of this well-written, expertly edited book is a compassion approach to long-term health care. This is long overdue and most welcome. While this textbook is outstanding for classroom use (it is presented in language that is free of jargon and could be easily understood by undergraduate majors), it is also a critical resource for current nursing home admin, those preparing for an admin position, and preceptors

(teachers/trainers). And, if you are a professor seeking a all-inclusive textbook (to keep costs as low as possible for your students), this large volume addresses a wide array of issues that should provide a semester-long experience. (Likewise, there are instructor-support materials available at the publisher's website. And, you know how those resources can make class prep considerably less arduous!) Likewise, review questions, case studies, and key terms are provided at the end of each chapter. (Obviously, this is extremely helpful to students as they prepare for exams).The structure of this text addresses both practical details (like patient demographics, laws, public policy, etc.) as well as more contemporary issues that need immediate attention (like the aging LGBTQ+ community and sustaining/fostering an all-inclusive, diverse population). This text also includes the integration of technology to ensure rapid, effective communication.And, certainly, this text addresses pertinent, pragmatic issues (like billing, Medicaid, working with the VA, etc.), it also provides invaluable information about the potential psychological issues facing patients. Topics such as depression, anxiety, isolation, and sleeplessness are examined in detail. This information assists admin to take a more empathetic approach to healthcare.As a whole, this text is informative, comprehensive, and promotes a compassionate approach to healthcare. It is a phenomenal text for professors shaping our future healthcare admin. Moreover, it is equally as effective for current admin seeking a quick refresher as well a contemporary view.Highly recommended!

I chose this book for review because of a role in marketing for long-term care facilities. I am also a registered nurse. I found the text to be complete and detailed with helpful case studies at the end of every chapter. From a marketing perspective, this textbook is helpful for understanding terminology and issues related to long-term care. For administrators, this gives a survey of all topics related to care managment, including payer sources, marketing, health issues for an agin population, biological and phycological issues, administrative duties, and state survey regulations.It will stay on my desk as a reference book for marketing planning and preparation. It is a priceless resource for anyone who is working in the field or studying to work in the field. This is an up-to-date perspective, which is helpful in this ever-changing environment of healthcare.Each chapter ends with key terms and references for that chapter's content. I found this helpful, because I didn't have to sort through the back of the book to look them up. Having them grouped by topic in chapters was a more organized way of finding it. There is also a table of contents it he beginning of the book that includes a list of the tables and figures in the book listed by topic.Overall, this is very organized and the content is presented in a way that is actually pleasant to read compared to some textbooks. I highly recommend it for nursing home administrators, nurses, marketing directors, and social workers in

the long-term care setting. I have not listed the topics from the table of contents here as that is available in the book description and in the online preview of the book. I don't often give 5 stars for a book, but this one is fully deserving of the rating!

I am currently working with a professor on his research project on patient rights. This is a comprehensive resource that does double duty as a reference book on the subject of long-term care in nursing home facilities, VA hospitals, etc., and a study guide that prepares students for the National Nursing Home Administrator exam. What's particularly useful is that it covers the problems and issues that arise in dealing with diverse populations. It offers detailed case studies that illuminate theoretical concepts. It is detailed while being accessible, a sign of good writing. While health care laws are constantly changing, it helps the reader get familiar with key concepts and issues that are regulated by the federal and state governments. Along the way, you're tested via review questions and a glossary explains key terms. My only criticism is that there appears to be no online component to this volume, which is unusual for a textbook. Many professors like to use online links so they can post it on Blackboard, for example. But overall this is an excellent resource on this subject.

Written in a purely academic format, the intended audience is either student or professional preparation. As such, this provides a solid overview of both the physical and psychosocial dimensions of nursing/long term care. From financial accountability to communication, a broad selection of topics is provided in an accessible format. Solid historical perspective provides a firm foundation while current and future trends are established; the author(s) do a good job with both present and future considerations. Citations and resources throughout. Appropriate for an Introduction or Refresher course - there is not a lot of advanced or specific information but instead, an ample overview.
